### Your Coverage from a VSP Doctor

Exam covered in full .....every 12 months

#### Prescription Glasses

Lenses covered in full.....every 12 months

- Single vision, lined bifocal, and lined trifocal lenses.
- Polycarbonate lenses for dependent children.

Frame .....every 24 months

- Frame of your choice covered up to \$ 150.
- Plus, 20% off any out-of-pocket costs.

Contact Lens Care .....every 12 months

When you choose contacts instead of glasses, your \$150 allowance applies to the cost of your contacts and the contact lens exam (fitting and evaluation). This exam is in addition to your vision exam to ensure proper fit of contacts.

You are required to pay the provider in full at the time of your appointment and submit a claim within a year from the date of service to VSP for partial reimbursement.
